Chairman's report

Al – It's been a good 12 months. We've had challenges, I've had personal challenges in the first part of the year. But we have maintained membership and revenue. We have demonstrated that we can keep running on a tight budget. The concerns we had a few years ago about needing to fold have been resolved. Our savings are such we can continue to operate for several years. But we need to work harder to attract more members. The best way is to be more active – including maintaining a strong presence on social media, and producing podcasts with transcripts that can become policy papers. Our activities have been of a high standard. The Gender dysphoria podcast had 9K views on YouTube alone. Our success with the GP crisis podcast has given us status among the GP community. Our posts on LinkedIn attract debate and attention. The importance of our role in protecting the independence of the medical profession remains more important than ever. We need to work on other topics than general practice - eg AHPRA's interference. The political shift we've seen overseas and that appears to be happening in Australia makes our role important as we can help shape health policy. It is important we get our members more active, and the executive need to be more active. We've worked out how to do our job better and learned a lot over the last 12 months.
